#### **Concept of Awards**

To recognize exemplary and distinguished activities/service to the UBC Faculty of Medicine (UBC FoM) in the areas of Continuing Medical Education/ Continuing Professional Development (CME/CPD).

Two awards are available:

- 1. *An award for Innovation in CME/CPD and***
- 2. *An award for Distinguished Service to the Realm of CME/CPD.***

Each award recipient receives an honorarium of \$1,000 and public recognition at the Faculty of Medicine Awards Reception.

The awards are recognized by the UBC FoM on an annual basis as part of the celebrations and activities currently in place to recognize winners of other similar awards.

UBC Division of Continuing Professional Development (UBC CPD) has an important role to promote the importance of continuing education as part of a physician's responsibility to lifelong learning.
